

## THE MINDSET OF A FLOURISHING WRITER THE PAIN AND HEALING PUT IN VERSE

Writing can be a wonderful outlet for selfdiscovery. Since high school, Megan has enjoyed expressing herself through writing specifically, through poetry. One poem, "This Girl That I Know," is one of the first she remembers writing. It describes her initial battles with herself, and her mental illness.

"I was suffering inside," recalls Megan. By the age of 22 and living at home, she says she was cutting herself frequently. That was when she heard about Catholic Charities Delaware House.

#### **BREAKING OUT OF ISOLATION**

"I was told that Delaware House had groups where I could interact with more people," Megan explains. "My first day was like walking into a world of groups and friends." Friends, she says she didn't have many of prior to joining the groups.

"One important aspect of treatment for many individuals who seek help for mental illness is group therapy," says Megan's Case Manager, Donna Futchko. "That's where Megan found a place to put a voice to her struggles in addition to writing."

"My first couple of years at Delaware House, I was in and out of the hospital," remembers Megan. Catholic Charities stayed by her side during these highs and lows. "Recovery is a process," explains Futchko. "Ideas and support 'tools' take time to put into action. Also, it can be challenging to find the right medication to get through daily routines and be a part of the community."

#### ADVOCATING HEALTH AND HAPPINESS

After two years of treatment, Megan was beginning to thrive. "I got it together and was out of the hospital for years. Suicidal thoughts were once in a blue moon, and I

was actually happy," she says. "Delaware House got me to open up and reach out."

When she heard about the Residential Program at Delaware House—which provides semi-supervised housing—Megan thought it would be the perfect first step toward branching out on her own. "I started to advocate for myself."

Within a year, she had moved into her own little apartment through the Residential Program.

"My mom can come over on weekends and sleep over, and I can have other family over, as well," she says excitedly.

## THERE'S NO PLACE LIKE HOME

Nancy is a kind, generous woman who enjoys simple things — she eats healthy meals, stays active by taking walks in the park in the Spring, volunteers to help children at Christmas, and feels it's important to have her family nearby. Four years ago, she was suffering from constant anxiety over how to afford her rent increase.

#### **CUTTING BACK ON EXPENSES**

Being a naturally frugal person, Nancy is careful to stretch every bit of her income. Back then, she used to resort to separating two-ply toilet paper into one-ply for it to last longer. But no amount of frugality could compete with a rent increase while living on Supplemental Security Income (SSI).

In 2014, Nancy turned to Catholic Charities Community Services as she was facing eviction. Through the Rapid Rehousing program, she found a nice apartment to move into and receives a small amount of assistance to pay her monthly rent. This change allows Nancy to remain within walking



distance of her sister, Peggy.

Joking that she would be a bag lady now if it weren't for Community Services, Nancy is very appreciative of the assistance she receives. "I'm overwhelmed and grateful by the support of Catholic Charities. They have shown so much kindness to me," she says.

#### FREEDOM FROM EVICTION ANXIETY

Being true to herself, Nancy is only willing to accept the exact amount of support she needs, and nothing more. When offered additional help— like a Thanksgiving Basket or holiday support—Nancy has selflessly declined, saying: "Please give it to people who need it more."

Her Catholic Charities Case Manager has seen a change in Nancy. "When I first met her, she was a scared and nervous woman—and very close to being evicted." But now, Mosudi Idowu says, without the stress of paying that rent increase on her own, she is stable and happy. "She's come a long way. She has a high spirit of commitment and even volunteers when she can."

Born on July 5th, Nancy grew up believing that the 4th of July fireworks were a celebration of her birthday. With her 80th birthday approaching this year, Nancy plans to celebrate her independence thanks to her own perseverance—and a little bit of help from Catholic Charities.

Sitting at home alone with nothing to do seemed to make Cheryl's depression worse. "I wanted to get out more, make friends and receive support to continue my recovery," recalls Cheryl. She found all that and more at Catholic Charities Program of Assertive Community Treatment (PACT).

A client for more than 15 years, Cheryl most appreciates the compassionate support of her counselors. "The meetings are helpful because I always learn new ways of managing my symptoms and I enjoy the friendships that have developed," says Cheryl.

The PACT program has been highly effective in helping individuals living with a mental health or substance dependence diagnosis manage their symptoms while living on their own. The individual needs and strengths of each client are assessed and every effort is made to improve their overall wellness, explains PACT Program Director for Burlington County, Crystal Smith. "Part of feeling good mentally and emotionally stems from physical wellbeing and looking one's best," says Smith. With this in mind, Smith established a partnership with a local hair styling academy to bring PACT clients once a month for services at no charge. Clients have their choice of haircuts, manicures, and pedicures.

Looking forward to the outing, Cheryl says, "I love PACT, it has become my family."

PACT counselors are available 24/7 to help promote the ongoing wellness and recovery of their clients, monitoring medication and encouraging them to achieve their highest level of functioning.

## FINDING HELP AND GIVING HELP



"From the time you walk in the door, you're greeted by somebody that you know is here to help you." This was Michelle's first impression of Catholic Charities Providence House Domestic Violence Services.

Michelle, a mother of two, was in an abusive relationship for 10 years without ever

defining it in those terms. "The abuse happens so gradually that it takes a while to wake up and see it for what it is," she says. When asked what made her realize she was being abused, Michelle answers that she told someone what her partner had done to her, and their response was enlightening: "They said, 'You need to get help.' And I said, 'What am I getting help for?'

#### THE TURNING POINT

The harassment and abuse had reached a level of fear that Michelle didn't know how to deal with. "I would flee from my home while my children were at school because I knew he would come back," she says. "I was just afraid." The turning point for Michelle was when, she says, "he decided I would be his punching bag."

It was in a book of resources that she found the hotline number for Providence House. "I just called...

and I started from there." Michelle explains that she was unaware not only that Catholic Charities offered domestic violence support services, but she barely knew they existed at all. But now, she refers everyone who confides in her to Providence House—whether they're a former victim of domestic violence—or someone with an abusive partner because "that was where [her] healing began."

#### A TIME TO SPEAK OUT

In fact, Michelle has turned her healing into helping others. In addition to serving as a founding member of the STOP (Survivors, Testimonies, Outreach, Prevention) Committee, she also provides speaking engagements on domestic violence, and has led trainings for local police departments.

When describing her experience at Providence House, she likens it to a hospital: You go to a hospital and you expect a doctor to tell you what's broken—and how you can take the steps to heal the hurt.

"Providence House not only saved my life, but empowered me to help others. They helped me believe in myself."

#### where to turn. She found her way to Catholic Charities El Centro. There she met caring, culturally competent staff who listened attentively and offered tissues as she cried, sharing her story. After 20 years working as a caregiver, Ana had

retired. Unfortunately, due to some bad circumstances out of her control, everything she had worked for was lost. Things got even worse when her abusive husband destroyed all of her identification documents.

By coming to El Centro, Ana was immediately provided with food and some groceries, emotional support, and most importantly, hope.

"Our staff understand those seeking our help because many have had to overcome similar barriers," said Ron Gering, Service Area Director, Catholic Charities Children and Family Services. "El Centro's programs are designed to tap into a person's resiliency and strengthen self-confidence."

#### THE SPIRIT TO OVERCOME

Today, nine years after her first visit to Delaware House, Megan is proud she's gone two and a half years without cutting herself, and that she hasn't been to the hospital in more than two years. "I have many good friends and memories. I've come to love and appreciate the staff of caring people."

"It's been my pleasure to assist Megan along her journey," says Futchko. "There's a spirit about Megan that will never give up." Recently, Megan has written a follow-up poem to that early prose, titled "Life Lived," which tells the tale of the things she has overcome.

# Catholic Charities Opened NEW AMBULATORY DETOX CLINIC IN TRENTON

Catholic Charities, Diocese of Trenton has opened a new ambulatory detox clinic to round out a full complement of addiction and mental health recovery treatment services. "The addition of this new clinic, offering safe and cost-effective treatment for individuals seeking recovery from opioid and other substance dependence, is very much needed," said Executive Director, Marlene Laó-Collins.

Offered at their Trenton campus located on North Clinton Avenue and Southard Street, this new program opened its doors in December 2017. "The Ambulatory Detox Clinic offers an alternative to hospitalization as an out-patient detox program. The value of the ambulatory detox to the community is that it provides a vital, comprehensive life-saving service, that is available to all in need," observed Director of Operations, Susan Loughery.

The Ambulatory Detox Clinic is the final component of the Certified Community Behavioral Health Clinic (CCBHC). This federally sponsored initiative integrates behavioral health services, substance abuse treatment, and primary care on the Trenton campus. Launched on July 1st 2017, the CCBHC has already produced measurable improvements in treatment outcomes.
