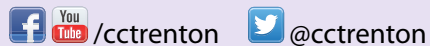

DONATION OPPORTUNITIES

A monetary donation will sustain Providence House Domestic Violence Services (PHDVS) in the following ways:

\$1,500 Funds an 8-week domestic violence education program

\$1,000 Contributes to a 5-night stay at the Safe House for one mother/child

\$750 Covers energy bill at the Safe House for two weeks

\$500 Feeds residents at the Safe House for two weeks

\$250 Provides personal care products for two months at the Safe House

\$125 Covers one child's art therapy session

FUNDRAISING OPPORTUNITIES
